

EMT Waiver

In consideration of the potential risk of injury while attending a Cielos event or event at the Crazy Diamond venue, I hereby, for myself and any minors I am a guardian to, knowingly and voluntarily enter into this waiver and release of liability and hereby waive any and all rights, claims, or causes of action of any kind whatsoever arising out of my participation in any Cielos event or medical care received at the aforementioned event, and do hereby release and forever discharge Cielos and medical staff, located at the Crazy Diamond, Ventucopa, California 93252, their affiliates, managers members, agents, attorneys, staff, volunteers, representatives, heirs, predecessors, successors, and assigns for any physical psychological injury, including but not limited to illness, paralysis, death, damages, economical or emotional loss, that I may suffer as a direct result of my participation in the aforementioned event, including traveling to and from an event associated with Cielos.

I am voluntarily participating in the aforementioned activity and I am participating in the activity entirely at my own risk. I am aware of the risks associated with traveling to and from as well as participating in the activity, which may include, but not limited to, physical or psychological injury, pain, suffering, illness, disfigurement, temporary or permanent disability (including paralysis), economic or emotional loss, and death. I understand that these injuries or outcomes may arise from my own or others' negligence, conditions related to travel, or the condition of the activity location(s). Nonetheless, I assume all related risks, both known or unknown to me, regarding my participation in this activity, including travel to, from, and during this activity.

I further agree and provide consent for the event and medical staff to take all life-saving procedures necessary in order to prevent potential injury or fatalities at all events at the Crazy Diamond venue relating to Cielos or alternative events located at the Crazy Diamond venue. I agree to indemnify and hold harmless Cielos event and events associated with the Crazy Diamond venue and all medical staff of any and all claims, suits, or actions of any kind whatsoever (regarding medical care or actions taken by medical and event staff) for liability, damages, compensation, or otherwise brought by me or anyone on my behalf, including attorney's fees and any related costs, if litigation arises pursuant to any claims made by me or anyone else acting on my behalf, regarding any and all medical care provided during the aforementioned activity, and provide my consent to have event and medical staff take all necessary actions and procedures if deemed necessary, to sustain life, control injury, prevent illness, or assist in medical attention. I give consent for event and medical staff to perform lifesaving

actions for myself and any minors I am a guardian to, in the case of an emergency or in the case of my inability to give consent due to unconsciousness, unresponsiveness, or any condition that prevents me from communicating with event staff and the medical team. I hereby hold harmless Cielos event and medical staff and all events associated with the Crazy Diamond venue, from any claims, suits of action, or accusations of any kind regarding medical care and actions taken by staff during the aforementioned activity, and acknowledge that all Cielos event and medical staff and their directors, officers, volunteers, representatives, and agents are not responsible for errors, omissions, acts of failure of any party.

I acknowledge that this activity may involve a test of a person's physical and mental limits and may carry with it the potential for death, serious injury, and property loss. The risks may include, but are not limited to, those caused by terrain, facilities, temperature, weather, lack of hydration, condition of participants, volunteers, spectators, event officials, medical staff, and/or producers of the event.

I acknowledge that I have carefully read this "Waiver and Release" and fully understand that it is a release of liability. I expressly agree to release and discharge Cielos events and all contracted event staff including medical personnel, and all of its affiliates from any and all claims or causes of action and I agree to voluntarily give up or waive any right that I otherwise have to bring legal action against Cielos events and medical staff for personal injury, property damage, or medical care provided on-site to prevent deathbed serious injury.

To the extent that statute or case of law does not prohibit releases for negligence, this release is also for negligence on the part of Cielos events and associated medical staff, its agents, and additional employees.

In the event that I should require medical care or treatment, I agree to be financially responsible for any costs incurred as a result of such treatment. I am aware and understand that I should carry my own health insurance, prescribed medications, and necessary supplies and/or medications needed for personal preservation, and/or which are recommended by my recommending providers.

In the event that I should require medical care and am unable to provide consent due to unconsciousness or unresponsiveness, I provide my consent to take all medical actions necessary to ensure my, or any minor(s) to who I am guardian to, safety and wellbeing. I will not take legal action regarding the care I receive at Cielos events or from within the Crazy Diamond venue and acknowledge that medical staff will take all measures necessary to ensure the safety and wellbeing of all attendees, including myself. Event

staff will provide sufficient care to me and any minors accompanying me to the best of their ability with the supplies on-site. In the case of an emergency where additional medical care is presumed necessary, event staff will call 911 for transportation off-site. Event and medical staff will take all medical precautions and procedures necessary to ensure proper treatment of on-site injuries, illnesses, or conditions, but is not accountable for, and not limited to, these injuries, illnesses, conditions, or outcomes of emergency situations on or off the Crazy Diamond venue location.

I further acknowledge that releases are not responsible for errors, omissions, acts, or failures to act of any party or entity conducting a specific event or activity on behalf of the Releases. In the event that I should require medical care or treatment, I authorize Cielos event and associated medical staff to provide all emergency medical care deemed necessary including but not limited to first aid, CPR, the use of AEDs, emergency medical transport, and sharing of medical information with medical personnel. I further agree to assume all costs involved and agree to be financially responsible for any costs incurred as a result of such treatment. I am aware and understand that I should carry my own health insurance.

I further acknowledge that this activity may involve a test of a person's physical and mental limits and may carry with it the potential for death, serious injury, and property loss. I agree not to participate in the aforementioned activity unless I am medically able, and properly prepared, and I agree to abide by the decisions of the event and medical staff regarding my participation and continued participation of the aforementioned activities and acknowledge that medical staff can deem me unsafe or unfit for the continuation of participation of said events.

In the event that any damage to equipment, facilities, or harm to staff occurs as a result of my or my family's willful actions, neglect, or recklessness, I acknowledge and agree to be held liable for any and all costs associated with any actions of neglect and recklessness.

I have read this document and understand it. I further understand that by signing this release, I voluntarily surrender certain legal rights.
